 13. The affiliation shall be withdrawn at any time if the college fails to fulfill the necessary terms and conditions of the University /State Govt. / UGC / NCTE/ any other regulatory authority having jurisdiction in the matter.
- B. The rules and regulations of the University in respect of affiliated colleges will be followed strictly.
- C. The norms of the University in respect of fees will be followed strictly. The fees will be Rs. 45,000.00 (Rupees Forty Five Thousand only) per student.
- D. Admission for this session will be made as per interim Order of the Hon'ble Calcutta High Court.

Dear Sir,

As directed by the Hon'ble Vice Chancellor, UGB, Malda, I have the pleasure to inform you that the University of Gour Banga decided to grant affiliation to the David Hare Teacher's Training College for the session 2012-2013 session subject to the following terms and conditions:

- A. The observations of the Inspection Report underneath will be complied with and a report thereof will be submitted at the earliest.
1. The college should strictly adhere to the fee-structure and intake capacity (100) recommended by the University of Gour Banga.
 2. The college in no case should deviate from the stipulation of holding classes in at least 180 working days during the session. An academic calendar confirming the plan should be submitted immediately.
 3. The college should follow the instructions of the University as regards the subjects to be taught and adhere to the NCTE norms as to the stipulated intake for method subjects offered by the college.
 4. The number of books has been found to be inadequate to cater to the needs and interests of 100 trainees. It is expected that before the commencement of the session, the library will be equipped with at least 250 titles.
 5. It has been found that the laboratories are not yet equipped with the necessary apparatus. Besides, seating arrangements for trainees are yet to be made. The college is expected to abide by the stipulations in this regard.
 6. The students should be provided with photocopier and internet facility to enable them to keep abreast of the changes.
 7. Incomplete Electrification Works to be completed before the commencement of classes and incomplete construction works of floors are to be completed as early as possible.
